Conditions of Permit:

1. Applicant agrees to do all work in accordance with the **Special Conditions** (Item 8 below) herein, all rules, regulations and ordinances of the City subject to inspection and approval by City Engineer.
2. Applicant will contact the Office of the City Engineer at least 24 hours prior to beginning work in order that inspection may be arranged.
3. The Contractor and/or Owner shall save, keep and hold harmless the City, its officers, agents, employees and volunteers from all damages, costs or expenses in law or equity that may at any time arise, or be set up because of damages to property or personal injury received by reason of or in the course of performing work which may be occasioned by any willful or negligent act or omission of the Contractor and/or Applicant, any of the Contractor's employees, or any subcontractors. The City will not be held liable for any accident, loss or damage to the work prior to its completion and acceptance.
4. Applicant agrees to pay any damages resulting to the City of Crescent City from the negligent or improper design, construction, or installation of the encroachment, and will restore the property crossed to its former state and so as not to have impaired unnecessarily its usefulness or will repay to the City of Crescent City cost of such restoration.
5. Except as specifically noted herein, all driveways, sidewalks, curbs and gutters, water lines, sewer lines, storm drains, pavement or other improvements under this permit become the property of the City and the Applicant hereby disclaims any legal title in same.
6. All debris (soil, concrete, pavement, wood, etc.) shall be removed and the work location shall be swept clean upon completion.
7. Work authorized under this permit must be performed within one year from date of approval, but may be extended for six months upon payment of \$25.00 fee.

GENERAL LIABILITY INSURANCE POLICY

Policy shall be for a minimum of \$1,000,000.

The City of Crescent City shall be named as an *additional insured* on this policy. The language contained therein should be: the City of Crescent City, its officials, officers, employees and volunteers are named in all liability policies described above as insureds as respects: A) activities performed for the City by or on behalf of the named insured, B) products and completed operations of the named insured, and C) premises owned, leased or used by the named insured.

WORKER'S COMPENSATION POLICY

Policy shall include a "Waiver of Subrogation" endorsement.
