PERMIT TERMS

A permit to connect to the municipal water system and to be provided water for the address indicated, is conditional. New mainline extensions or connection of major water users will be considered on a case by case basis. Water use and connection permits will only be issued in conjunction with a building permit and will become void if the building permit becomes inactive. All improvements connecting to the water system shall be constructed according to the direction of the Public Works Department. The permit is subject to, and there is incorporated by reference, all ordinances of the Crescent City Municipal Code, resolutions of the City Council and administrative rules and procedures set out by the City of Crescent City, now in effect or hereafter promulgated. Other than as required by law for meetings of the City Council, no individual notice will be given Permittee of any change in terms of the Permit and Permittee's agreement to the revised terms shall be designated by Permittee's continuing to receive service, or continuing to intend to connect to the system, under permit, following the imposition of the new terms. Permittee shall comply with all orders of the City instructing Permittee to limit water consumption to proscribed levels and for designated uses. Permittee shall install any water pressure control and capacity devices required by City. The permit is not transferable.

AGREEMENT OF OWNER

I/We hereby apply to the City of Crescent City for a conditional permit to connect to the municipal water system and to be conditionally provided water for the address indicated. The undersigned, jointly and severally, agrees to comply with all terms and conditions set forth in the Conditional Water Permit, ordinances of the Crescent City Municipal Code, resolutions of the City Council and administrative rules and procedures set out by the City of Crescent City, now in effect or hereafter promulgated and to pay all costs, charges, penalties, fees, levies and assessments from time to time so imposed. I/We hereby grant the City of Crescent City a blanket easement upon, across, over and under all the property at the address indicated for all acts necessary to maintain the functional existence of the water system, including but not limited to, ingress, egress, installation, replacing, repairing and maintaining all water utilities and to read the water meter. I/We hereby irrevocably dedicate to the City of Crescent City all water line improvements constructed, including but not limited to lateral lines. I/We agree to remain responsible to repair all improvements located at the address indicated. I/We agree to perform all acts and execute further documents necessary to effectuate the intent of this Agreement. In the event of default I/We agree to pay all expenses of any nature, whether incurred in or out of court, including but limited to reasonable attorney's fees and costs, that City may deem necessary or proper in connection with the satisfaction of the indebtedness. I have read and understood the permit terms above. Following any termination of service, a new permit must be obtained to restore service. Any portion of this agreement found void or invalid shall be severed from the remaining terms.
